# **ANNOUNCEMENT**

San Francisco Public Works (Public Works) announces a Request for Qualifications (RFQ) for prequalification of general contractors for the ESER 2010 Fire Station 5 Replacement Project located in District 5 at 1301 Turk Street, San Francisco, CA. The scope of work includes the complete and total demolition the existing 3-story fire station including foundations; hazardous material abatement; removal of underground fuel tanks; reconstruction of streets and sidewalks; construction of new three story fire station building with elevator. The new fire station includes 5 apparatus bays, associated equipment storage, living and dining areas and a fitness room. The construction cost for this project is estimated at \$14M. The construction schedule is 15 months from NTP to substantial completion, and 2 months from substantial to final completion, for a total of 17 months.

# **SECTION 1**

# **INTRODUCTION**

San Francisco Public Works (Public Works) is issuing this Request for Qualifications ("RFQ") in search of candidates ("Candidates") who have the necessary qualifications as set forth in this RFQ to be prequalified to respond to the forthcoming Request for Bids (RFB) to provide general construction services for the ESER 2010 Fire Station 5 facility located in District 5 at 1301 Turk Street, San Francisco, CA. Whether a Candidate has such qualifications will be determined through the evaluation process described in Section 3(c) of this RFQ. Candidates chosen through this process ("Qualified Respondents") will be notified of their eligibility to submit proposals in response to a request for bids construction services in conjunction with the Project. Only Qualified Respondents will be eligible to submit a bid for construction services.

Public Works will select a general contractor (GC) based on the following two-step process: (1) this Request For Qualifications ("RFQ"), by which Public Works seeks candidates ("Candidates") who meet the qualification criteria set forth in this RFQ and whom Public works will then invite to participate in step (2) Request For Proposals ("RFP"). Public Works will evaluate the bids of Qualified Respondents based on quantitative criteria to determine the successful GC. Candidates who do not meet the qualification criteria of this RFQ will be disqualified from participating in step two of the competition.

Candidates responding to this RFQ do so with the understanding that they are not guaranteed the award of any contract and/or work. Public Works may cancel the selection process at any time for any reason or no reason.

This RFQ describes the qualifications needed, describes the anticipated scope of the work, and defines the selection process.

All requirements of the San Francisco Contract Monitoring Division (CMD) apply to this RFQ and any subsequent contract. Detailed CMD information is contained in Section 5.

# A. THE PROJECT

The City is committed to excellent public architecture and is seeking responses from GC firms who have a track record of successful performance in civic projects that strive to balance critical architecture with function and the evolving expectations for more sustainable approaches to design and construction. The new Fire Station 5 Facility will be required to meet the City's green building design principles delineated in the City and County of San Francisco Environment Code, as well as meet LEED v2009 Gold Certification for New Construction requirement.

# **SECTION 2**

# **REQUIREMENTS & PREQUALIFICATION OF THE GENERAL CONTRACTOR**

The City will not accept bids from any Candidate who does not meet the minimum qualifications under this RFQ. City staff will review the responses to this RFQ.

In order to submit a proposal in response to the forthcoming RFP, each Candidate must:

- 1. Fully complete the RFQ Candidate Contact Information form, Parts I, II, III of the Prequalification Application Questionnaire with a passing score as defined therein;
- 2. Fully complete Relevant Project Experience (Part IV), fulfilling 4 out of 6 criteria;
- 3. Provide all materials requested in this RFQ;
- 4. Receive approval from Public Works as a Qualified Respondent;
- 5. Be willing and able to comply with the City's contracting requirements set forth below in Section 5.

If two (2) or more business entities plan to submit a proposal as part of a Joint Venture, each entity within the Joint Venture must be separately prequalified.

Each Prequalification Application Questionnaire e must be signed under penalty of perjury in the manner designated at the end of the Candidate Contact Information form, by an individual who has the legal authority to bind the Candidate on whose behalf that person is signing. If any information provided by a Candidate becomes inaccurate, the Candidate must immediately notify Public Works and provide updated accurate information in writing, under penalty of perjury.

As soon as is practicable after the prequalification process is complete, Public Works will issue a Request for Proposals (RFP) to the Qualified Respondents.

#### **SECTION 3**

#### **INFORMATION MEETING, SUBMISSION, EVALUATION, & APPEAL PROCESS**

#### A. INFORMATION MEETING

An RFQ Informational Conference will be held at **2:00 p.m. on October 20th, 2016** at Public Works' 4<sup>th</sup> floor Main Conference Room, 30 Van Ness Avenue, San Francisco, CA. #### B. SUBMISSION PROCESS

This RFQ will be uploaded to Public Works' download website (www.sfpublicworks.org/biddocs) under the Electronic Bid Documents List, Construction Category, **RFQ: GC PREQUALIFICATION – ESER 2010 Fire Station 5**. Completed Prequalification Application Questionnaire must be submitted by <u>2:00 PM, October 28th, 2016</u>. The list of Qualified Respondents is scheduled to be posted on the Public Works website on October 31st, 2016. Candidates receiving a determination of "Not Qualified" will be notified by email of their status.

Each Candidate shall submit three (3) copies of completed Candidate Contact Information form, Parts I, II, and III and IV in a sealed envelope. Completed Prequalification Application Questionnaire shall be delivered to the below address on or before due date/time – postmarks will not be accepted and other means of transmission, including facsimile, will not be accepted.

Public Works may refuse to grant prequalification status where the requested information and materials are not provided. There is no appeal from a denial due to an incomplete application; however, the candidate will be informed which documents or information is required to complete the application and shall be permitted to submit a complete application.

#### C. EVALUATION PROCESS

1. Written Submittal Evaluation (WSE): City staff will review all proposals and the Prequalification Application Questionnaire of this RFQ.

The Prequalification Application Questionnaire consists of four parts. To prequalify, a Candidate must fully complete the Candidate Contact Information form, Parts I, II, and III and IV, as applicable. In the case of Joint Ventures, each entity within the Joint Venture must fill out each section, Parts I, II, III and IV, individually. The City reserves the right to rescind any candidate's prequalified status if it is determined that the facts provided by the Candidate are inaccurate.

<u>Part I, Organization, History and Organizational Performance:</u> Candidates are required to provide company organization information, company licenses, and related history.

<u>Part II, Essential Requirements for Qualification:</u> Candidates are required to answer questions regarding history of financial and professional responsibility, including Prior Experience Criteria relevant to this project.

<u>Part III, References Questionnaire</u>: Candidates are required to provide client references who can confirm the candidates past performance in meeting aggressive schedules on-time and within budget. In addition project information should be provided.

<u>Part IV, Relevant Project Experience</u>: Candidates are required to complete a minimum technical qualification questionnaire.

#### D. APPEALS PROCESS

Where a timely and complete Prequalification Application Questionnaire results in a not-qualified determination, the Candidate may appeal. The Candidate may file a letter of appeal to Public Works delivered to Public Works-Project Management, 30 Van Ness Avenue, Suite 4100, San Francisco, CA 94102, Attn: Ms. Gabriella Judd Cirelli, no later than five (5) business days after receipt of determination of "Not Qualified" email.. Other means of transmission, including facsimile, will not be accepted. Unless a timely appeal is filed, the Candidate waives any and all rights to challenge the decision of the Public Works, whether by administrative process, judicial process or any other legal process or proceeding.

If the Candidate files a complete and timely letter of appeal, a review of the appeal shall commence soon after receipt of the request. The review shall be an informal process conducted by Public Works or its designee and will be based upon the information submitted by the Candidate in its letter of appeal; clarification of previously submitted information is allowed, but no new information can be submitted and/or considered in the appeal. Public Works will notify the Candidate in writing of its decision at the conclusion of the review. The decision of Public Works is final. The date for submission and opening of bids for a specific project will not be delayed or postponed to allow for completion of an appeal process.

# **SECTION 4**

# TERMS AND CONDITIONS GOVERNING THIS RFQ

#### A. COSTS OF RESPONDING, RETENTION BY PUBLIC WORKS OF QUESTIONNAIRES AND RELATED DOCUMENTS

Public Works accepts no financial responsibility for any costs incurred by a Candidate in responding to this RFQ. Completed questionnaires and any other documents or materials submitted in response to this RFQ shall, upon submission, become the property of the Public Works and may be used by Public Works in any way Public Works deems appropriate.

#### **B. RESERVATIONS OF RIGHTS BY PUBLIC WORKS**

The issuance of this RFQ does not constitute an agreement by Public Works that any subsequent selection process will occur or that any contract will be entered into by Public Works. Public Works expressly reserves the right at any time to:

- Waive any defect or informality in any questionnaire or the procedure set forth in this RFQ;
- Reject any or all Questionnaires;
- Issue a new request for qualifications in lieu of this RFQ;
- Change the subsequent selection process;
- Procure all or any portion of the Work by any other means; and
- Determine that the Work will not be pursued.

#### **SECTION 5**

#### **CITY AND COUNTY OF SAN FRANCISCO CONTRACTING REQUIREMENTS**

It is advisable that Candidates who wish to do business with the City and County of San Francisco (City) immediately initiate measures to comply with the City's contracting requirements. These requirements are not a part of the Public Works prequalification process; however failure to comply can delay the finalization of any future City-related Contract.

#### A. Business Tax Registration

At the time of contract award, the successful GC must have a current and valid San Francisco Businesses Tax Certificate. This certificate can be obtained by properly submitting to the City's Tax Collector a completed Business Tax Registration Declaration and paying the registration fee. The registration fee is \$25, \$150, \$250 or \$500, depending on the type and size of your business. The current forms of such declaration can be found at the following website links:

#### B. Certification of Chapter 12B Compliance

At the time of contract award, the successful GC must be compliant with San Francisco Administrative Code Chapter 12B, the Equal Benefits Ordinance. In order to become compliant with the Equal Benefits Ordinance, Candidates must submit to the San Francisco Contract Monitoring Division a form titled SAN FRANCISCO ADMINISTRATIVE CODE CHAPTERS 12B & 12C DECLARATION: NONDISCRIMINATION IN CONTRACTS AND BENEFITS (CMD-12B-101). Supporting documentation is required. CMD staff will review all submittals and work with the Candidate to achieve compliance.

# Do not wait until the contract is awarded to begin the compliance process or you may lose the award. Candidates are advised to submit all required Equal Benefits documentation with their bid.

#### **E. Insurance Requirements**

The successful GC Candidate will be required to comply with the City's insurance requirements. Information regarding Insurance requirements will be included in the Request for Proposal package following the qualification process.

#### F. CMD Subcontracting Goals

Chapter 14B Local Business Enterprise (LBE) and Non-Discrimination Ordinance apply to this project. This project will have a LBE Subcontracting Requirement of 20%. The Contractor awarded this contract will be required to meet or exceed the project's LBE subcontracting requirement.

#### **G. Bonding Requirements**

Performance Bonds and Labor and Material Bonds for 100% of the contract amount will be required when City or Public Works requests contractor to provide bonds prior to issuance of Notice to Proceed with the construction work.
